If you discover your content has been shared without permission, we're ready to assist. We operate in compliance with the [Digital Services Act \(DSA\)](#) and [Digital Millennium Copyright Act \(DMCA\)](#), ensuring your content receives the protection it deserves.

Our Security Features

1. **Time-Limited Access** We generate temporary access links that expire automatically, preventing unauthorized sharing of your content.
2. **Anti-Scraping Protection** Our systems actively detect and block automated attempts to download content without permission.
3. **Digital Fingerprinting** Each piece of content contains unique digital markers, allowing us to track its origin if it appears elsewhere.
4. **Watermarking System** We provide tools to add watermarks to your content, making unauthorized use more difficult.
5. **Age Verification** We verify all users' ages to ensure your content is only accessed by appropriate audiences.
6. **Enhanced Account Security** Two-factor authentication keeps your account secure from unauthorized access.

Resolution of the Issue

1. Complaint Review Process:

- Upon receipt of your complaint, we will promptly review the matter.
- Complaints concerning **non-consensual use of images** or **illegal content** will be reviewed and resolved within **24 hours**.
- All other complaints will be reviewed and resolved within **7 days**.

2. Verification Requirement:

- Nymph may request **video verification** from the person filing the complaint.
- Refusal to undergo verification grants us the right to reject the complaint.

3. Actions Taken:

- If the Content is found to be unlawful, non-consensual, or in breach of our Terms of Use, we will promptly remove it.
- While we are not obligated to inform you of the outcome, we may notify you via email or a Platform notification.
